

NOTICE INVITING e-TENDER (Extension of Dates)

To provide Pest Control Management Service at the Office of West Bengal Industrial Development Corporation Limited, at “PROTITI”, 23, Abanindranath Thakur Sarani, (Camac Street), Kolkata 700 017.

e-Tenders in prescribed format are invited by ‘West Bengal Industrial Development Corporation Ltd.’ from bona fide, experienced & reputed vendors of good financial standing in three steps bidding system, as specified below:-

- Step-I : Earnest Money Deposit,
- Step-II : Technical Bid,
- Step-III : Price Bid,

To provide Pest Control Management Service at the Office of West Bengal Industrial Development Corporation Limited, at “PROTITI”, 23, Abanindranath Thakur Sarani, (Camac Street), Kolkata 700 017.

To purchase the Tender Document, the bidders will have to submit tender purchase fee amounting to Rs.500/- (Rupees five hundred only) by Cash/ Demand Draft/ Pay Order in favor of West Bengal Industrial Development Corporation Ltd. payable at Kolkata. This amount is non-refundable under any circumstances. The Tender Document shall be available online at www.wbtenders.gov.in and also in the HRD Division of WBIDC Ltd. In case the e-Tender Document is downloaded online, scanned copy of the draft/ pay order against the tender purchase fee, must be uploaded online.

The selected vendor will be appointed for a period of three years to provide Pest Control management services

2. Eligibility Criteria and Essential Technical requirement: The Agency/Company must fulfill the following criteria:-

- a) Prior experience of at least ten (10) years in providing Pest Control Management Service, in any reputed Government Organization/ Public Sector/ Corporate Sector /industry. The experience should be supported by an end user certificate of satisfactory performance.
- b) Must be a company incorporated under the Companies Act or a partnership firm registered under the Partnership Act/ LPA Act having registration with valid registration number and having PT Registration.
- c) Should have at least one office in Kolkata.
- d) Should be able to initiate the work immediately or as stated by WBIDC. The selected vendors will have to perform the job as per time suitable for WBIDC.
- e) There should not be any legal proceeding(s) and / or Industrial dispute(s) related to

claiming of wages or any other payment related matters, initiated by any present or previous employee of the bidder / any partner of the bidder (if the bidder is a partnership firm). This will have to be supported by an appropriate Declaration in the form of an Affidavit which, if found false, would not only lead to criminal prosecution, but may also lead to termination of the contract and award of the work to another vendor at the bidders risk and cost.

3. EMD:- Rs. 20,000/- (Rupees Twenty Thousand Only) in the form of Demand Draft/Pay Order, drawn on any Nationalized Bank in favor of “WEST BENGAL INDUSTRIAL DEVELOPMENT CORPORATION LIMITED”.

The bid without requisite Earnest Money and/ or not in the prescribed Performa will not be considered & bids of such Bidders shall be rejected. Earnest Money Deposit will be converted into interest free Security Deposit in case of successful bidder. Necessary receipt may be collected from the Accounts Section in favor of the same. On successful completion of the contract (if extended, then after completion of the extended period of contract) the same will be refunded to the bidder, after any applicable adjustment thereof.

In case of unsuccessful bidders Earnest Money will be refunded as soon as possible by WBIDC, upon selection of vendors.
