3. Backdrop as per approved design with lights to project.
- 4) Logos of C&I Department and WBIDC (printed on vinyl pasted on sunboard and fixed on cyma wall with double side adhesive tape)
- 5) Book rack : 02 nos
- 6) Glass fishbowl for dropping of business cards: 01 no.
