F. ELIGIBILITY CRITERIA:-

• **Financial Eligibility Criteria:**

The applicant should have an Average Annual Turnover in last 3 FYs ending 31st March 2016 not less than 30 lakh per year.

• **Technical Eligibility Criteria:**

The applicants should have completed similar type of AMC work with value not less than Rs. 10 lakhs per year, with proven technical and financial capacity in last 3 FYs ending 31st March 2016 and possessing required infrastructure for the above work. Contractor should follow Indian Electricity Rule, 1956 as amended and other related norms strictly while executing the work.

- Must be a company incorporated under the Companies Act or a partnership firm registered under the Partnership Act/ LPA Act having registration with valid registration number and having PT Registration, should be registered under the Employees Provident Funds Misc. Provisions Act, 1952, Employees State Insurance Act Registration, Service Tax registration/ Clearance Certificate, IT Registration.

- There should not be any legal proceeding(s) and / or Industrial dispute(s) related to

claiming of wages or any other payment related matters, initiated by any present or previous employee of the bidder / any partner of the bidder (if the bidder is a partnership firm). This will have to be supported by an appropriate Declaration in the form of an Affidavit which, if found false, would not only lead to criminal prosecution, but may also lead to termination of the contract and award of the work to another vendor at the bidders risk and cost.
