7. Battery bank installation and synchronization with UPS system.
8. Checking of all Batteries will have uniform internal resistance that determine the longevity of the batteries.
9. To provide the GRAFLIM sheet to use in between batteries and battery racks to avoid fire blast due to acid spillage.
10. Using proper PPE and safety tools at the time of battery installation and checking.
11. Quarterly battery discharge test at warranty period.
12. Yearly IR test at warranty period.
13. Using calibrated instruments for battery measurements.
14. Re-torque the terminal bolts once in every three months.
15. Frequent update on battery characteristics/ room temperature if there is any change.
16. The work, mentioned above, to be completed successfully and full satisfaction of the departmental engineer and UPS maintenance agency entrusted for this UPS maintenance in written no objection within **15**(fifteen) days from the date of issuance of work order, and the **Defect Liability Period** for this work is **3**(three) years after completion of this work in all respect.
17. If battery will fail within **Defect Liability Period** then it should be replaced within two days to avoid any penal action.
