All materials/items on “AS IS WHERE IS BASIS” will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the materials/items proposed to be disposed off. No complaint, whatsoever, would be entertained after the submission of bid.
4. The highest bidder will be awarded.
5. The successful bidder will submit EMD value of Rs.10,000/-.
6. The successful bidder will have to deposit the total quoted amount (inclusive of all tax and duties as applicable) in full. Installment payment is not allowed.

16. The Successful bidder indemnifies WBIDC or any of its employees or associates or WBTPPO personnel or its associates for any cause of damage or loss of scrap material undergone during the process of lifting of the produce.
